Investment - Completions

Summary

- Omni Bridgeway announces the successful completion of two North American investments
- Omni Bridgeway expects to generate total income of approximately US\$4.0m from the completion of an US litigation in Fund 1 and Funds 2 and 3 have received the final tranche of income from a Canadian law firm portfolio investment, increasing the total income to CA\$1.0m.

US Investment

Omni Bridgeway Limited (**Omni Bridgeway**) announces the resolution of a case funded in the United States by Fund 1. All appeals in respect of the action have now been exhausted. Fund 1 expects to receive income from completion of the investment resulting in the following metrics (subject to prevailing foreign exchange rates):

Canadian Law Firm Portfolio Announcements

Omni Bridgeway confirms that Funds 2 and 3 have received the final tranche of income from a Canadian law firm portfolio investment. This was the first investment of its kind in Canada entered into by Omni Bridgeway following a number of similar US law firm portfolio investments made by Fund 1. The investment is expected to generate the following metrics for Funds 2 and 3 (subject to prevailing foreign exchange rates):
